- (g) Dispute(s) relating to or arising from decisions of the Returning Officer after nominations shall be determined within seven (7) daysof lodging the dispute(s) with the Commission which dispute(s) be lodged within 24 hours of occurrence.
- (h) Pursuant to the provisions of regulation 57 (1) and (2) of the Elections (General) Regulations, 2012 every political party and every independent candidate at the by-election shall submit to

the Commission names of the chief agents on or before Wednesday, 8th March, 2017.

- (i) The campaign period for purposes of the Wednesday, 22nd March, 2017, by-election shall commence on, Thursday, 19th January, 2017 cease on Sunday, 19th March, 2017 being 48 hours before the by-election day.
- (*j*) The campaign time shall run from 7.00 a.m. to 6.00 p.m. during the campaign period.
- (k) If the by-election is contested, the poll will take place on Wednesday, 22nd March, 2017.
